### RV "Community for a Cause" Contest

#### Official Rules

##### The Promotion:

Promotion Period: The Promotion begins at 8:00 a.m. CDST on Tuesday, November 27<sup>th</sup>, 2018 and ends at 5:00 p.m. CDST on Monday, December 31<sup>st</sup>, 2018. All votes must be received by 5:00 p.m. CDST on Monday, December 31<sup>st</sup>, 2018.

##### Eligibility:

1. No purchase, registration fee, payment, or monetary donation is required to participate in the RV Community for a Cause contest [Promotion].
2. Voters must be eighteen (18) years of age or older.

  - a. Votes may also be submitted by mail. The voting form must be fully completed, including the voters first name, last name, and email address; voters must use their own name. Send only one form per stamped, self-addressed envelope to "My Vote for Community for a Cause" c/o River Valley Bank, Marketing Department, P.O. Box 777, Wausau, WI 54402-0777.
4. Only one vote per individual each day of the Promotion.
5. Votes that are incomplete, tampered with, illegible, inaccurate, forged, irregular in any way, or otherwise not in compliance with these Official Rules will be disqualified.
6. All submissions become the property of Sponsor and will not be returned.
7. The Sponsor reserves the right, in their sole discretion, to cancel, modify, terminate, or suspend the Promotion if fraud, technical failure, tampering, or any other causes beyond the control of Sponsor inhibit, corrupt, destroy, or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, and Sponsor may void suspect submissions and/or disqualify any individual who engages in or attempts any such activity. Any attempt to damage the operation of this Promotion is unlawful and subject to legal action.
8. By submitting the voting form, voter agrees to full and unconditional acceptance of these Official Rules, the decisions of Sponsor, which are final and binding in all respects, and warrants that the voter is eligible to participate in this Promotion.

##### Prizes:

Donation "Prizes" will be awarded as follows:

1<sup>st</sup> = \$1,000

2<sup>nd</sup> = \$600

3<sup>rd</sup> = \$400

### Prize Distribution:

At the end of the voting period, the top three vote getters will be awarded a tiered monetary amount as noted in "Prizes". All decisions about the final vote count will be at the sole discretion of the Sponsor. In the event of a tie, the Sponsor will draw the placement from the two or more tied organizations. All decisions of the Sponsor are final and binding. Odds of winning depend upon the number of eligible submitted votes received.

Winning organizations will be notified by telephone and (unless waived by Sponsor in its sole discretion) may be required to complete an affidavit of eligibility, release of liability, and proof of 501 (c) status, all of which must be returned to the Sponsor within fourteen (14) days after notification, or the next highest vote getter may be selected by the Sponsor. Any prize notification or prize returned to the Sponsor as undeliverable will be rewarded to the next highest vote getter. No prize substitutions, transfers, or assignment of prizes allowed.
